Subject: Wisconsin's Implementation of Best Available Retrofit Technology (BART)

Dear Ms. Hedman:

The Wisconsin Department of Natural Resources (WDNR) hereby submits its implementation of Chapter NR 433, Protection of Visibility by Application of BART. This submittal is one major component of Wisconsin's State Implementation Plan (SIP) for compliance with the federal Regional Haze Rule issued in 1999 and modified in 2005 (64 FR 35714 and 70 FR 39104). The remaining portions of Wisconsin's Regional Haze SIP, such as plans to address 2018 reasonable further progress (RFP) goals for visibility protection in federal Class I Areas, will be submitted under separate cover letter.

The WDNR determined that ten (10) facilities are subject to BART. This included nine (9) electric generating units (EGUs) and one (1) non-EGU source. The original EGU and non-EGU BART technical support documents prepared by the WDNR are included as attachments, as well as the final BART analysis and summary of changes. In addition, modeling demonstrations are provided for three (3) other non-EGU sources that are not subject to BART. Furthermore, a draft Administrative Order (AO) and draft permit revisions are provided.

The following are some key dates related to WDNR's implementation of BART requirements:

- March 6, 2009 BART analysis submitted to WDNR by Georgia-Pacific (GP) Consumer Products LP (included as attachment)
- July 29, 2010 Public hearing conducted in Madison, WI (proof of hearing and summary / response to comments included as attachment)
- January 13, 2011 Regional Haze SIP, including BART analysis, submitted to the Federal Land Managers (FLMs) for a 60-day review and comment period.
- July 1, 2011 Revised Regional Haze SIP, including BART analysis, submitted to the FLMs for another 60-day review and comment period.
- September 13, 2011 Public hearing conducted in Madison, WI (proof of hearing and summary / response to comments included as attachment)



The WDNR has the legal authority under Wisconsin law to adopt and implement these requested SIP revisions. Section 285.11 (6), Wis. Stats., authorizes the WDNR to develop and revise the SIP for prevention, abatement, and control of air pollution.

In accordance with the April 6, 2011 McCabe Memo, one paper copy of the SIP revision documents are enclosed. In addition, an electronic copy of these documents is provided as well on an enclosed CD.
