- Section 2-Plan Narrative
 - Narrative, updated (use DNR Narrative Template). The narrative or separate document should also describe:
 - Whether any applied manure or process wastewater ran off the application site for surface applications on frozen or snow-covered ground the previous winter.
 - List of fields that received nutrients from a source other than manure or process wastewater generated by the farm. These nutrient applications should also show up in the SnapPlus files.
 - List of fields removed from the NMP in the previous 12 months.

 - Copies of tile line/outlet monitoring (if applicable)
 - Copies of groundwater and bedrock depth monitoring (if applicable)
 - Copies of manure irrigation monitoring (if applicable)

 - Other information requested by the Department in writing or in the permit.
