### 2022 WADABLE STREAMS TROUT POPULATIONS SUMMARY REPORT UPPER FOX AND WOLF RIVER FISH MANAGEMENT AREA

Survey Objectives
In 2022, the Wisconsin Department of Natural Resources (DNR) conducted electrofishing surveys on wadable streams located in Green Lake, Marquette, Shawano, Waushara and Waupaca counties in order to provide insight and direction for the future management of these waters. Primary sampling objectives of these surveys were to characterize relative abundance and size structure for all trout and overall ecological integrity through an index of biotic integrity (IBI) based on all fish species present in the sampled stretches. The following report is a summary of trout metrics for all streams and sites surveyed in 2022. Contact the appropriate county fisheries biologist to request them.

### **Survey Methods**

All streams are sampled according to the DNR's wadable streams monitoring protocols.

- TREND survey sites are sampled annually while ROTATION sites are sampled on a rotational frequency (three, six or twelve years).
- All sampling sites are electrofished with either a towed barge or backpack electrofishing unit.
- Sampling distance is at least 35 times the mean stream width or a minimum of 330 feet (100 meters), whichever is greater.
- All gamefish are identified to species, measured for length and examined for fin-clips. In at least one survey site per stream, all fish species are collected and counted. If multiple sites are designated for a stream, only one site needs to be sampled for
- Metrics used to describe fish populations include catch per unit effort (CPUE), length frequency distribution and index of biotic integrity (IBI).

This past survey season the Upper Fox and Wolf River work unit was able to survey 8.6 miles of stream. 2,058 brook trout, 4,813 brown trout and 12 rainbow trout were handled, along with many other species of fish which were used to calculate the IBI scores on the various stretches of stream.

#### **Metric Descriptions**

- Catch per unit effort (CPUE) is an indirect method of measuring fish population relative abundance. For all trout surveys, we typically quantify CPUE by the number and size of trout captured per mile of stream. CPUE indexes are compared to statewide streams by percentile (PCTL). For example, if a CPUE is in the 90th percentile, it is higher than 90% of the other CPUEs in the state. CPUE percentiles can also be used to categorize trout abundance by benchmark percentiles, with the 33rd percentile being the lowest density, the 66th percentile being moderate density, the 90th percentile being a high density and the 95th percentile being a very high density.
- The Index of Biotic Integrity (IBI) is a rating of environmental quality based on fish assemblages at the site. Scores of 90-100 would indicate excellent quality while scores less than 30 would indicate poor quality. Our analysis utilizes the IBI for Wisconsin coldwater streams where the maximum daily mean water temperature is usually less than 22°C (71.6°F). Coolwater and warmwater IBIs may be summarized for some sites as appropriate.
- Length frequency distribution is a graphical representation of the percentage of fish captured by 1-inch size intervals.
