Meeting Synopsis

Introductions of state and FEMA staff were made (meeting attendance list included below). Fritz then summarized the goals of RiskMAP and the timeline for the project; provided basic information about the National Flood Insurance Program (NFIP); gave broad details about what the affected communities can expect to see out of this project; and explained what types of data we would like to obtain from the county/communities. Details on the project specifics and scope of work, impacts the communities might see from the new data, and hazard mitigation topics were also briefly discussed.

Chris expanded on the engineering behind the floodplain update. Zone A areas will remain Zone As, be model backed with current engineering standards and include elevations. This project is currently funded through Draft work maps.

The Outagamie County Hazard Mitigation Plan has expired but is being updated. The Waupaca County Hazard Mitigation Plan is current and expires in 2026.

During the meeting there were questions and discussion concerning who can apply for mitigation grants, residents, or a jurisdictional authority. The mapping process was discussed as stream survey is starting and residents may see surveyors working. The timeline was discussed, and it was reinforced to please reach out if there are any questions. It was mentioned that updates would be posted to the DNR website, including materials from this meeting.
