# Presentation on the Pelican River Forest Legacy Project (Phase 2) – Ron Gropp, Clint Miller, Bethany Olmstead

- FY23 funding consideration for Forest Legacy Funds
- 3<sup>rd</sup> time the conservation fund has looked at this property
- under contract to purchase ~69,000 acres
- Clint and Bethany are the "public face" of this project
- TCF is DC based a conservation based non-profit
- TCF expects to conserve ~500,000 acres over the next few years
- past projects Brule St. Croix Legacy Forest globally important pine barrens connects significant amount of already conserved lands
- Pelican River resides in northern forest forest legacy area (FLA) Mostly in Oneida County, dips into Langlade and over into Forest
  - o provides significant connectivity, rare and common species habitat, public recreation
  - o largest block of unprotected privately owned forest remaining in WI
  - o property is currently FSC certified and will continue if purchased by TCF
  - o enrolled in MFL program
- Project scoring
  - scores HIGH in the strategic category
  - o scores HIGH in the importance category environmental, social and economic benefits
    - economic fact sheet
  - project scoring for threatened Threats are subdivision and land conversion; hope is to prevent poor forest management and a reduction or elimination of public access; if the project goes through, we can avoid those threats and outcomes
- Pelican River Phase 1 earlier this year (2021) 12,500 acres were acquired (no objections from Joint Finance Committee) – allocated entire allotment for Knowles Nelson Funding to Phase 1 (that's why looking for Legacy Funds for Phase 2)
  - this easement does come with motorized access and a road maintenance endowment fund
- Phase 2 is roughly 58,000 acres
  - Would use a combination of Forest Legacy Program (\$15,000) and KN funds as match (\$5

#### Timeline

- Sept 14 projects need to be entered into federal system with letter from state lead to FS Regional Forester
- Sept 29/30 Region 9 FLP mock panel
- Oct 18 Final project entered into federal system
- Nov 17/18 national FLP panel convenes
- After Jan 1 of 2022 should know how project ranked but it wouldn't officially get funded until federal FY23 budget is passed

- What is TCF's long term game plan?
  - TCF often purchase, ensures conservation easement and then sell the underlying fee title (business minded – TCF will not be long-term owners) – goal would be for that sale to be to a single owner to maintain it as a working forest to contribute to forest economy
