On January 5, 2022, the Wisconsin Department of Natural Resources (Department) received your request for certificate of completion (COC) of exploration work at the Bend deposit in Taylor county and release of the bond provided by Aquila Resources USA (Aquila). The Department previously informed Gold Resources, as purchaser of Aquila's corporate assets, that the surety bond covered previous exploration activities in Taylor County, Marathon County, and any future exploration conducted under the license issued to Aquila.
