BIDDING REQUIREMENTS

 - a. Bids will be made by <u>species</u> for each tract.

b. Estimated volumes and utilization specifications are listed on individual sale prospectus maps. Bid according to volumes listed on individual sale prospectus and/or maps.

c. The $\underline{high \ bidder}$ will be determined by the $\underline{greatest \ total \ bid}$ for each tract.

d. Bids will be opened in random order.

UTILIZATION

CONTRACT EXTENSIONS

Contract extensions will not be granted without justifiable reason. Justification will be determined by the Department of Natural Resources. 
