Request for approval of Wetland and Waterway Permits

I ask that the DNR promptly process and approve the permits needed for the Line 5 Project to move forward.

- The relocation of a segment of Line 5 is needed in order to remove the pipeline from the Bad River Reservation while maintaining the safe transportation of essential energy used by northern Wisconsin and the region.
- The project has been designed to minimize impacts on wetlands and waterbodies.
- Enbridge's proposed route maintains service of Line 5 in a corridor that avoids sensitive resources that other routes would impact such as Copper Falls State Park, Chequamegon-Nicolet National Forest, and a crossing of the Namekagon River.
