West Star Lake Campground, sites 1701-1718, is in the northeast portion of the Northern Highland American Legion State Forest on the northeast corner of Star Lake. The lake provides clear water swimming opportunities and the campground has a designated beach area to enjoy. Star Lake is also known for quality fishing and boating experiences, and the campground has a boat landing available for registered campers. You may access the Star Lake Nature Trail from the campground. All sites in this campground are on a non-reservable basis. **Upon arrival, campers should find an available campsite and register at the self-registration station located near the campground entrance, or register with the campground manager.**

Non-resident\$38/annual

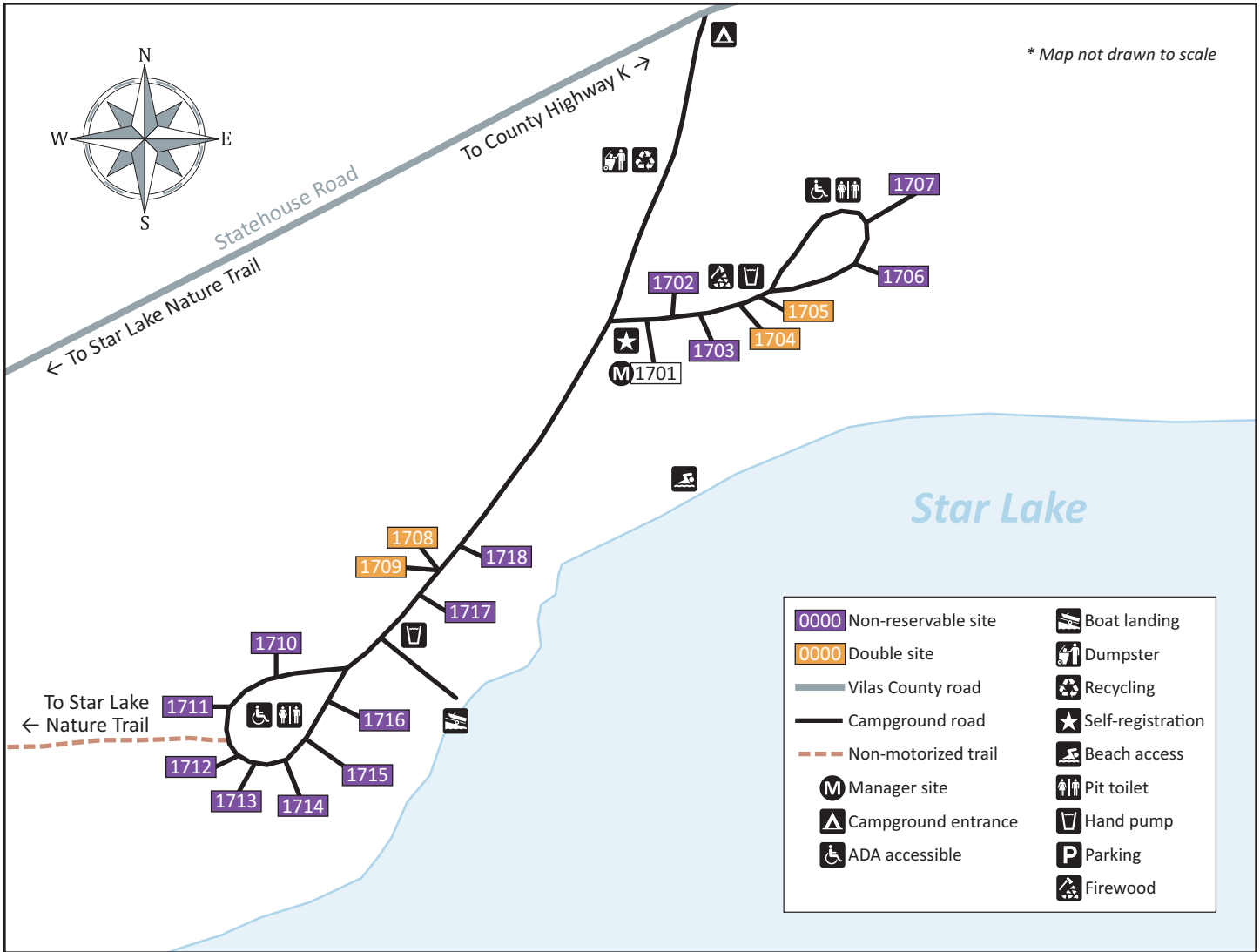

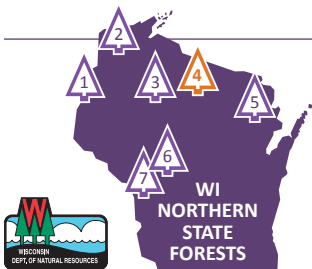

Campground Rules

- Upon availability, all campers must register at a: 1) campground kiosk, 2) visitor station, or 3) with a campground manager.
- **Checkout Time:** Must vacate site by 3 p.m. on the last day of the permit.
- **Campground/Day-use Areas and Closing Time:** Campground closed to nonregistered campers 11 p.m. to 6 a.m.
- **Pets** must be on a leash at all times and not left unattended.
- **Noise** may not interfere with the enjoyment of the forest by others.
- **Generators** may be used from 10 a.m. to 5 p.m.
- **Camping Party:** A “non-family group” may not exceed six persons. A “family” is limited to parents with their dependent children and not more than two guests.
- A **State Parks and Forest Admission Sticker** is required for camping.
- For complete rules and regulations, see Chapter NR 45, Wis. Admin. Code, or contact DNR Law Enforcement.
