Data collected during this event will be entered into SWIMS by River Alliance staff with the support of the Wisconsin Department of Natural Resources. To assure data quality, the department has requested that coordinators submit vouchers to the department. However, to decrease the workload of both you and the WDNR regional department staff, you are being asked to select only one voucher specimen to represent a species found in a waterbody. If the Wisconsin DNR does not already have a voucher of that specimen in that waterbody. The purpose of this document is to determine which vouchers are needed while capturing all the sites within a waterbody that voucher is to represent. If you feel that more than one voucher is warranted, you may submit multiple vouchers per waterbody.

Directions:

1. By waterbody, organize your volunteers' bags of specimens along with the corresponding datasheet
2. For each waterbody, complete a table below for each species reported by noting the site name, latitude and longitude found on the bag and the datasheet
3. Enter a "Y" in the verified column if you can indeed verify that they found the species of interest based upon the specimen. If you cannot verify it or it was a case of mistaken identity, enter "N"
4. Refer to <http://dnr.wi.gov/lakes/invasives/AISBVWaterbody.aspx> to determine if the plant or animal has been previously documented in that particular waterbody.
5. If it has not, set aside ONE voucher for each species per waterbody. Note from which site the voucher was taken in the "Voucher" column by entering a "Y"
6. Vouchers should be submitted per directions on <http://dnr.wi.gov/topic/invasives/report.html>
