TOWNS OF ROYALTON AND LITTLE WOLF ORDINANCE NO I-1984 REVISED IN 1987

An Ordinance To Regulate Water Traffic, Boating and Water Sports upon the Waters of Bear Lake, located in the Towns of Royalton and Little Wolf, in Waupaca County, and Prescribing Penalties for violation thereof.

The Town Boards of Royalton and Little Wolf, Wisconsin do ordain as follows:

Section \_\_.01 Boating regulations, chapter W.D.N.R. 5 of the Wisconsin administrative code and the following sections of the Wisconsin Statutes for 1983-84 are hereby adopted and made a part and portion of this ordinance for the Towns of Royalton and Little Wolf and that ss30.50 to ss30.773 of said chapter 30 is hereby renewed by references as set forth in full.

Section \_\_.02 (A) It shall be unlawful to operate any water craft at any time on Bear Lake in the Towns of Royalton and Little Wolf, Waupaca County Wisconsin, except in the marked ski area, at a speed greater than Slow-No-Wake.

(B) It shall be unlawful in the Towns of Royalton and Little Wolf to operate water craft during the hours from one half hour after sunset to sunrise at a speed greater than Slow-No-Wake.

(C) "Slow-No-Wake means that speed at which a boat moves as slowly as possible while maintaining steerage control.

Section \_\_.03 It shall be unlawful for any person at any time to water ski, surf board or participate in a similar activity or to operate a water craft pulling a skier, skiers, surf board or similar device outside of the marked ski area, on the South end of Bear Lake in the Towns of Royalton and Little Wolf, Waupaca County Wisconsin.

Section \_\_.04 It shall be unlawful for any person to ski, surf board or participate in a similar activity or to operate a water craft pulling a skier, skiers, surf board or similar device upon Bear Lake in the Towns of Royalton and Little Wolf in Waupaca County Wisconsin except between the hours of 11:00 AM in the morning until sunset.

The time of day referred to above shall be the official time of the Waupaca County Sheriff Department.

Section \_\_.05 It shall be unlawful for any person to ski, surf board or participate in a similar activity or to operate a water craft pulling a skier, skiers, surf board or similar device on Bear Lake in the Towns of Royalton and Little Wolf in Waupaca County Wisconsin, at any time except in a counterclock-wise direction.

Section \_\_.06 Notwithstanding any of the provisions of the preceeding sections of this ordinance, the Towns of Royalton and Little Wolf may issue permits for the purpose of conducting water shows, water skiing shows and spectacles by the public, private groups or organizations. Said permits shall be obtained from the respective Town in which the activity will take place. Applications shall be made to the Town Board at least sixty (60) days prior to the event. All activities performed at a speed greater than Slow-No-Wake will be performed in the marked ski area.

Section .07 If any portion of the ordinance, regulation or law be held unconstitutional, the remainder of such ordinance, regulation or law shall remain in full force and effect.

Section .08 This ordinance No. 1 shall be in effect from May 1st until October 1st.

Section .09 Penalties. Any person or corporation who shall violate any of the provisions of this ordinance shall upon conviction, thereof, be punished for said violation by a forfeiture of not more than fifty dollars (\$50.00) for the first offense and shall forfeit not more than one hundred (\$100.00) upon conviction of the same offense a 2nd or subsequent time within one year.
