
The City of Crystal Falls respectfully submits this report as per provisions in the above noted article regarding the Crystal Falls Hydroelectric license.

**Exotic Species Annual Monitoring Report**


Dear Ms. Magalie R. Salas:

On July 26, 2010 Crystal Falls city employee Dave Graff and MDNR's fisheries biologist Arnold Abramson canoed the shoreline from a point approximately 1.5 miles upstream of the dam down to the boat landing on the eastern shore of the impoundment.

During the float two samples were found which appeared to be Eurasian Milfoil. These samples were thought to have been gathered near Frenchman's Rock which is located about 1300' upstream of the "*Limit of Monitoring*" specified in Article 411 of the license agreement. On August 18, Arnold and Dave set out to collect more samples and positively identify, measure, take pictures and GPS the patch of Eurasian Milfoil. However no Eurasian Milfoil could be found. After consultation and agreement with MDNR's biologist Arnold Abramson and MDNR fisheries biologist Jessica Mistak, the city shall continue to monitor on an annual basis the reservoir with the ability to positively identify, mark, and GPS on future river floats.

We hereby file one original and eight copies of this letter with the Commission. A copy of this report is also being submitted to Michigan Department of Natural Resources and U.S. Fish and Wildlife Service.
