

ROLLING STONE LAKE PROTECTION & REHABILITATION DISTRICT
SANITARY SURVEY, PHASE II

SUMMARY REPORT

The District has contracted with Digger's Plumbing & Electrical of White Lake, WI, a certified plumber and certified soil tester, to perform a sanitary survey of all private septic systems in Sections 11, 12, 13, and 14 of the Town of Ainsworth (Town 34 North, Range 12 East) surrounding Rolling Stone Lake, to be inspected in a three phase sanitary inspection plan. Phase I covering those systems installed prior to 1970 or for which there were no records was completed in 1993-1994. Phase II covering all systems installed after 1970 and prior to October, 1980 or for which there were no records, was completed in 1994-1995. Phase III, which will cover those systems installed from 1980 through 1993 or for which there are no records, will be performed in 1995-1996. Phase III will complete the project.

This report covers Phase II. The contractor evaluated the soil conditions adjacent to each privy and visually inspected and measured the distance from the lake and the dwelling to determine compliance with the existing plumbing code.

For holding tanks, the contractor located and pumped the existing tank and inspected same for compliance with the plumbing code. He also visually inspected and measured its distance from the lake and the dwelling to determine compliance with the existing plumbing code.

For conventional (tank and field) systems, the contractor located and pumped the existing tank, located and inspected the drainfield, and made one boring adjacent to the existing drainfield to evaluate existing soil conditions. He dug one hole with a backhoe. He also visually inspected and measured the distance from the lake and the dwelling to determine compliance with the existing plumbing code.

In Phase II, 41 systems were inspected: 19 systems failed (46%). All findings have been reported to the individual property owner and to the Langlade County Director of Land Records and Regulations (formerly Zoning Administrator). Becky Frisch, Zoning Administrator, along with DILHR, will perform a spot check of the Phase II properties in April, 1995, and those property owners with failed systems will have until July 1, 1996 to bring their systems up to code.

The following is a complete list of those systems checked and the results.

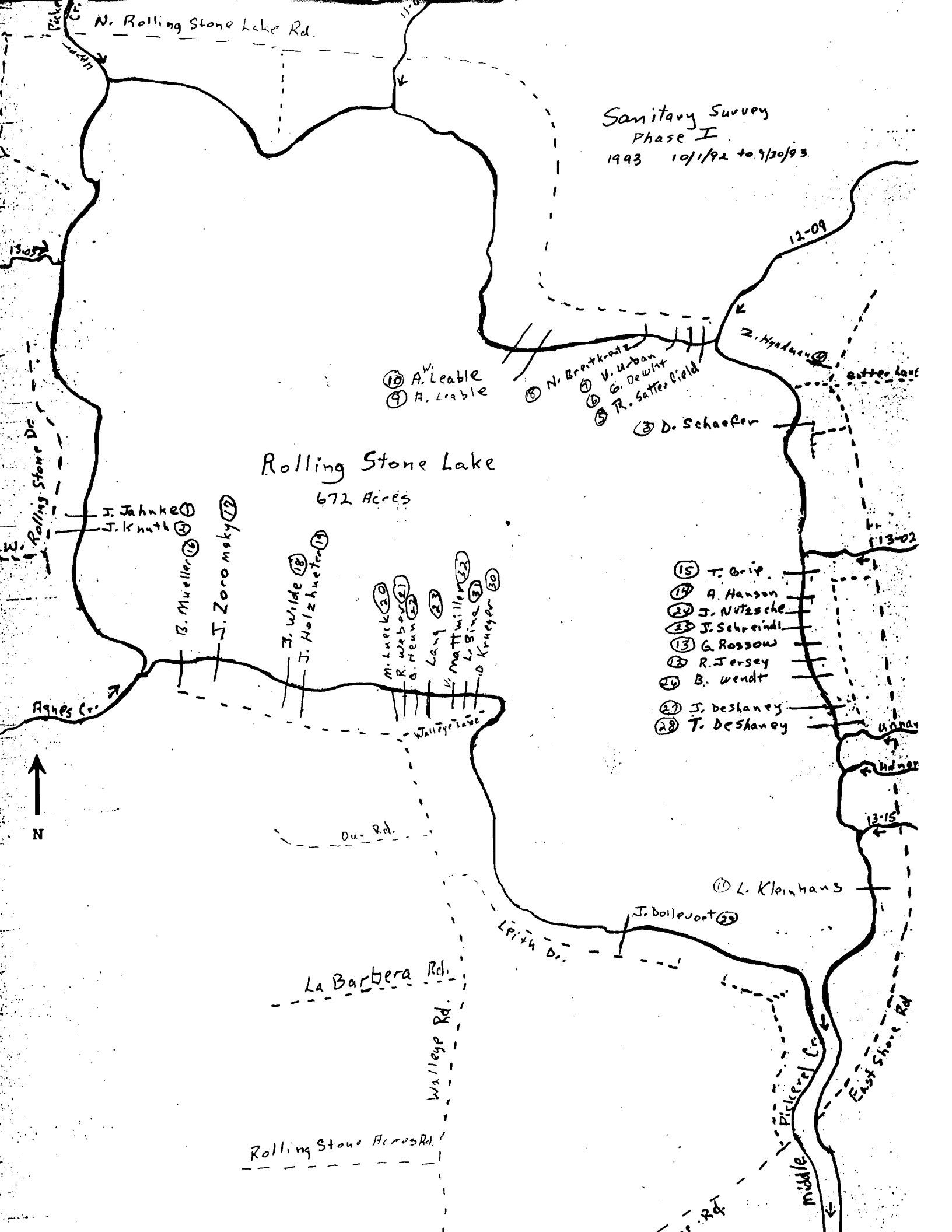

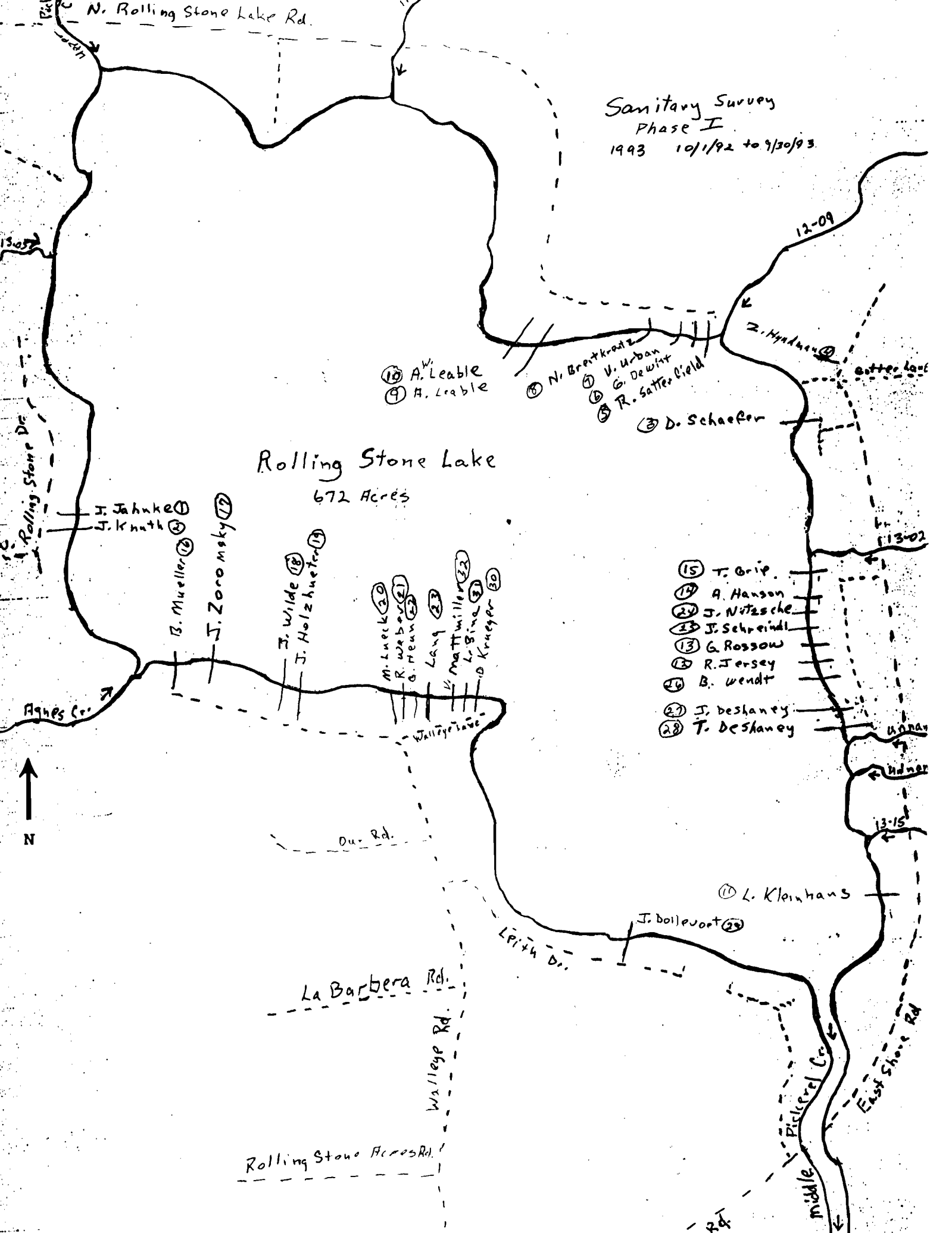
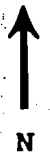
