Subject: Amendment to the *Dane County Water Quality Plan*, Revising the Oregon Urban Service Area Boundary and Environmental Corridors in the Town of Oregon.

Dear Mr. Mesbah:

We have completed our review of the subject amendment request that was submitted to the Department on June 17, 2010 by the Capital Area Regional Planning Commission. The Department hereby approves this amendment request which adds 8.9 acres to the Oregon Urban Service Area, west of Alpine Parkway and south of Netherwood Road in the Town of Oregon. Planned development for the amendment area includes 2.71 acres for the future site of First Presbyterian Church, 0.44 acres for residential development of two housing units, 0.49 acres of right-of-way, and 0.6 acres for stormwater management. Approximately 4.7 acres will be open space, no environmental corridors are proposed (see attached Map 1).

The proposed amendment was requested by the Village of Oregon on March 2, 2010 and was adopted by the Capital Area Regional Planning Commission per Resolution CARPC No. 2010-7 on May 13, 2010.

The approval of this sewer service area amendment does not constitute approval of any other local, state, or federal permit that may be required for sewer construction or associated land development activities.

If you believe that you have a right to challenge this decision, you should know that the Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions must be filed. For judicial review of a decision pursuant to sections 227.52 and 227.53, Wis. Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to file your petition with the appropriate circuit court and serve the petition on the Department. Such a petition for judicial review must name the Department of Natural Resources as the respondent.

To request a contested case hearing pursuant to section 227.42, Wis. Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to serve a petition for hearing on the Secretary of the Department of Natural Resources. All requests for contested case hearings must be made in accordance with section NR 2.05(5), Wis. Adm. Code, and served on the Secretary in accordance with

section NR 2.03, Wis. Adm. Code. The filing of a request for a contested case hearing does not extend the 30 day period for filing a petition for judicial review.

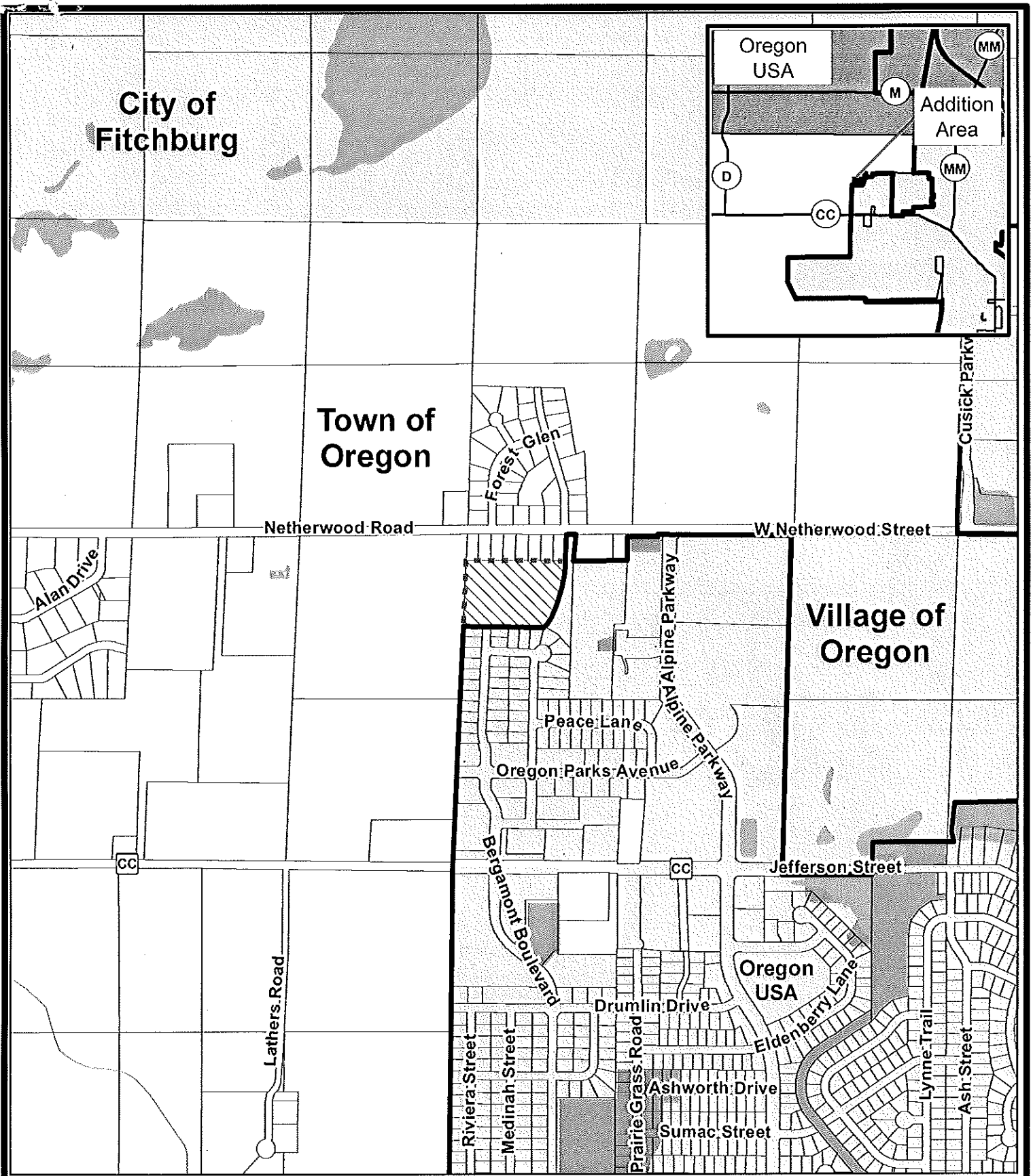


