Bayfield County Lakes Forum Completes Communication – Outreach project

Thanks to a DNR Small Lake Planning Grant awarded to the Bayfield County Lakes Forum, our county saw a number of benefits this past year . . . benefits for our lakes and for all who enjoy them. The grant, along with some creative fundraising and volunteerism, helped the BCLF succeed in greatly improving its ability to communicate with lake groups, shoreland property owners, lake users, political leaders and the general public. The BCLF also was able to help educate and train many individuals using these funds.

“This grant allowed us to accomplish many things that benefit our lakes,” said BCLF President Jim Brakken of Cable. “Receiving \$3,000 from the DNR, made it possible for us to publish our ‘prototype’ newsletter, revise and upgrade our website and send folks to lake education events.”

“With the help from this grant, 5,000 BCLF newsletters were published and distributed. They contained articles that encourage responsible use of our water resources and help folks make sound decisions regarding their waterfront properties. The feedback we received was all great. The funds also allowed us to send 44 folks from our county to the Northwest Lakes Conference and 11 more to Clean Boats – Clean Waters training. The CB-CW training gives participants in-depth knowledge of aquatic invasive species and qualifies people to work as landing monitors,” he concluded.

The BCLF grant was matched by over \$1,900 invested in the project by the BCLF along with contributions from its Directors. In addition, over 800 hours of work were donated by over 70 individuals supporting the project.

“This project also allowed us to create a new BCLF logo and revise and publish our membership brochure,” said Brakken. “Without this grant and the DNR’s Small Grant Program, we would not have been able to conduct these important outreach and communication projects,” he said. “Several of our regional partner county-wide lake groups are now looking into similar efforts.”

“This \$3,000 grant was awarded to the BCLF by the Wisconsin Department of Natural Resources. It is funded by the marine fuel tax also known as the ‘motor boat gas tax’, Brakken added. “It’s the tax we all pay when we buy gas for our boats. No additional taxes or funds are used. These grants are wonderful opportunities for lake organizations to educate folks about the sensitive nature of our waters without impacting the Bayfield County or the Wisconsin State budget,” he said.

The BCLF is a citizen volunteer organization not linked with the Bayfield County government. It represents over 20 lake associations and one lake district as well as the many non-organized lakes and streams in the county. The BCLF works to preserve and enhance the scenic, natural, recreational and economic values of Bayfield County lakes, streams and shorelands.
