Purpose: The St. Louis River and adjacent portions of Lake Superior are federally designated as an Area of Concern. This federal designation places waterbodies within Areas of Concern on the 303(d) list of impaired waters. This project involves evaluating current data and data gaps in 303(d) listed waters and to identify new additions to the 303(d) list in the Lake Superior Basin.

Objective: The WDNR is actively developing and pursuing the Area of Concern delisting targets. Achieving these targets will remove the St. Louis River and portions of Lake Superior from the Area of Concern designation. This could also effectively remove individual waterbodies within the AOC from the 303(d) list. In this process we have realized there is an abundant amount of existing and historical data that is relevant to our management needs. However, this data is spread out among many entities and in many various formats. These agencies and/or partners include: USGS, EPA, MPCA, USFWS, MDNR, universities, tribes, and citizen groups. The specific objective would be to facilitate data exchange and compilation, conduct data analyses, and evaluate water bodies for possible impairment and inclusion on the 303d list. This step is an efficient approach to meeting EPA reporting requirements for Measure SP 12.

Comments: Project Category 1: EPA Performance Measure SP 12 for federal reporting purposes.

Because there is a lot of research and data available concerning Lake Superior and the St. Louis River AOC, this approach is the most efficient method of determining current status of Lake Superior Basin water quality, including waters listed for impairments. Analyses/compilation of this data will also provide us the baseline information to help develop a strategy to achieve delisting.

Outcome: Performance Measures:

- 1) Identify all data sources for Lake Superior Basin, including the St. Louis River AOC by one month into project.
- 2) Meet with contacts to plan data exchange/coordination.
- 3) Start organizing data in a database compatible format. Investigate possible inclusion into SWIMS database.
- 4) In process, develop metadata.
- 5) Conduct data analyses; produce summary.
