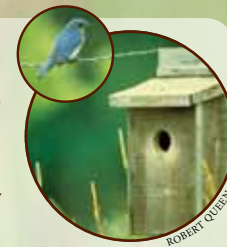

WILDLIFE

28.4¢ of each Fish & Wildlife dollar
\$29.2 million total
179 staff
23.9% of Fish & Wildlife-funded positions

- Assisted 32,494 interpretive program participants
- Helped host a youth outdoor expo attracting 3,000 students
- Expanded the National Archery in the Schools Program and hosted the largest indoor archery tournament in Wisconsin for over 700 students
- Conducted copper bullet demonstrations across the state as an action item of the Lead Action Plan
- Counted the elk herd at 150 animals and moved a small group of elk to expand their range
- Made 5,804 telemetry location determinations and 13,110 telemetry mortality checks during the last elk year (May 13, 2010, to May 19, 2011) and gave 31 elk presentations to 833 participants
- Continued CWD surveillance in southern Wisconsin and sampled over 4,500 deer
- Initiated comprehensive deer research projects in northwest and east central Wisconsin
- Involved hunters in assessing wildlife populations using surveys and deer registration forms
- Collected waterfowl and mammal harvest and age data, conducted license surveys and banded 11,000 birds
- Continued to be a national leader in using surveys for birds difficult to detect by normal survey methods: owls, nightjars, marsh birds
- Initiated the second bear population study using tetracycline
- Recorded a 2010 bear harvest of 5,133, the highest regulated bear harvest on record
- Conducted the Wisconsin spring waterfowl breeding survey with results in 2010 of 386,501 ducks and 165,853 geese
- Partnered with conservation clubs to release 55,000 pheasants on 71 public hunting sites
- Provided wildlife watching opportunities
- Developed, with partners, a Sharp-tailed Grouse Management Plan
- Completed a beaver survey in northern Wisconsin
- Initiated a long-term research effort to better understand bobcat ecology in southern Wisconsin
- Implemented an online turkey registration system and a telephone/online turkey harvest reporting system
- Used turkey, pheasant and duck stamp revenue for wetland, grassland, savanna and forestry projects
- Expanded the number of duck hunting zones
- Acquired and developed wetland and grassland habitat
- Initiated the 473,900-acre Southwest Wisconsin Grassland and Stream Conservation Area project
- Managed 178 state wildlife areas across 620,000 acres for hunting, trapping, fishing, wildlife watching and more

- Added 5,397 acres of wildlife area land through fee title and easement acquisition
- Launched the Voluntary Public Access Program, which added 12,000 acres of new public hunting land
- Developed non-forest biomass harvest guidelines
- Developed the Wild Rice Plan
- Conducted deer research focusing on fawn predation, buck mortality, and using vehicle collisions as a population size index
- Investigated techniques to restore lake shorelands and assessed wildlife response to lake shoreland restoration in northern Wisconsin

FISHERIES

- Sampled over 800 lake, river and stream sites to assess fish population and habitat health
- Managed fisheries in 15,000 lakes and 44,000 miles of streams
- Completed construction of the research vessel *RV Coregonus*, which will be used for survey work on Lake Michigan and replaces the 74-year-old *RV Barney Devine*
- Developed a management plan to re-establish spotted musky in Green Bay in cooperation with Michigan DNR
- Raised and stocked over 7.6 million fish
- Improved and maintained habitat on 57 trout streams
- Implemented a bilingual summer youth fishing outreach program at a Latino community center
- Introduced fishing skills and aquatic ecology concepts to 35,000 youth and their families
- Renovated Wild Rose Hatchery's coolwater rearing facilities for walleye, sturgeon, northern pike and musky with production expected to meet or exceed design goals
- Provided technical support for science-based management of several fish species statewide, including muskellunge, walleye, bass, trout, lake sturgeon, catfish and panfish
- Conducted collaborative research to understand factors that would favor bass or walleye dominance in Wisconsin lakes
- Leveraged expertise and regional multi-state partnerships to conduct research in support of fisheries in Wisconsin's rivers and Great Lakes tributaries
- Studied coldwater stream fisheries adaptation to Wisconsin's changing climate and developed best trout management strategies
- Researched the genetics of walleye and musky, and used findings to develop guidelines for maximizing healthy fisheries
- Studied the impact of angling on walleye age, size and populations

- Funded nine new or renovated boat access sites across the state

- Maintained the DNR managed lands website so people can find a place to hunt and fish
- Maintained the DNR boat access website so people can find a place to launch their boats

- Implemented internet chat function on the DNR website
- Recruited business support specialists to provide personalized training and support to more than 1,300 license agents
- Managed computer systems and vendor network supporting the sale of over 3 million fishing, hunting and trapping licenses
- Maintained an easy-to-use automated licensing system that integrates hunting and fishing, recreational vehicles and safety education
- Developed direct interfaces between electronic citations, the licensing system and the courts
- Distributed millions of regulation pamphlets/brochures

- Held over 975 hunter education courses taught by volunteers who trained over 25,000 students

- Issued 5,302 citations and 7,786 warnings
- Enforced fishing, hunting and trapping laws
- Entered over 400 individuals into the Wildlife Violator Compact
- Educated anglers and boaters about VHS
- Sponsored, in cooperation with volunteers, over 115 Learn to Hunt events with over 1,700 participants
- Conducted outreach and education about Wisconsin's Hunter Recruitment and Retention Program and goals

- Provided online information for access points to public hunting on state lands
- Managed DNR website and implemented a Gov delivery system allowing customers to subscribe to email, text messages and RSS feeds for specific topics and updates
- Ensured the future of hunting, fishing and trapping through educational programs
- Organized forums for fishing and hunting groups, government agencies, legislators and the public to participate in hunting and fishing policy making
- Managed and distributed 54 County Conservation Aids grants totaling \$148,053 and eight Urban Wildlife Abatement and Control grants totaling \$24,968
- Provided Sport Fish Restoration and Recreational Boating Facilities Funding for boat access facilities totaling \$854,820
